Sexuality, Education and Activism

Rémy Bonny (Executive Director Forbidden colors) on the Masterclass by Dorottya Rédai

On the 29th of March, RHEA co-organized a Masterclass on sexuality and gender education. The class focused on the evolution of this education during the Orbán-legislation in Hungary and was given by Dorottya Rédai. Dorottya Rédai is a well-known Hungarian activist and laureate of the P&V Foundation Citizenship Award 2022.

Exclusively for the readers of our newsletter, RHEA spoke with Rémy Bonny, Executive Director of Forbidden-colours and introductory speaker at the event.

How is Forbidden colours connected to the fight in Hungary?

As Brussels-based LGBTIQ+ organization we work on delivering human rights and democracy for LGBTIQ+ persons in Europe. We discovered the first attempt to introduce the anti-LGBTIQ+ propaganda law in 2021 in Hungary and brought it to the attention of the world media. For years, we have been monitoring the anti-LGBTIQ+ movement in Europe, and unfortunately the Hungarian government plays an important role in it.

We have been running an EU-wide campaign in cooperation with our Hungarian partner organizations to join an EU lawsuit against Hungary's anti-LGBTIQ+ law. 15 member states and the European Parliament agreed to our request to join the European Commission in the lawsuit. This makes it the largest lawsuit in the history of the EU in number of member states joining. It really shows that LGBTIQ+ rights belong to the core norms and values of the EU, and that we finally found a way to stand up for every queer person in the EU.

It is clear that a lot has changed in Hungary in a short period of time. If we should believe the polls, Belgium is also getting more polarized.

According to you, how does that affect the future of LGBTIQ+-rights and visibility?

Anti-LGBTIQ+ attacks are no longer limited to Hungary in the EU. We've seen politicians becoming increasingly hostile towards the LGBTIQ+ communities in Poland, Italy, The Netherlands, France but also in Belgium. The far-right is becoming stronger everywhere. As LGBTIQ+ movement we need to more actively work on depolarization in society. If we don't stop this anti-democracy movement it will stay getting stronger, and LGBTIQ+ people will be the first

victims.

What were the most important takeaways from the Masterclass for you?

Achievements in human rights should never be taken for granted. Up to 2010, the Hungarian government was actually making progress on democracy and human rights, including LGBTIQ+ rights. In 2008, they were one of the first countries in the world to introduce registered partnerships for same-sex couples. But everything changed when Viktor Orban took over in 2010. One of the first things he did was changing the constitution by writing in it that marriage is a union between opposite sex partners. Later he banned legal gender changes, adoption by same-sex parents, etc. It shows that democracy and human rights should not take for granted. Next to fighting for equality, we, as democrats, must also work on our resilience.




